ORDER

In partial modification and in continuation of the earlier Orders issued, vide earlier order No K/DDMA/CORONAREPORTS/01/303/1/96 Dated :19th April, 2021 and No. K/DDMA/CORONAVIRUS/17/2021/17 Dated: 26th April, 2021, I, Sri Kailash Karthik N, IAS, District Magistrate, Kamrup and as Chairman of District Disaster Management Authority, Kamrup in continuation of the above mentioned Order and in exercise of the powers conferred in me, under Section 34 (h) of the Disaster Management Act, 2005, in order to contain further spread of COVID-19 in the district, do hereby recommend that there will be closure of classes for all Educational Institutions (Government and Non-Government) from Pre-primary section to University level along with Hostels and Coaching Institutions for a period of 15 (fifteen) days. However, online mode of Education should be made available for the students.

This order shall come into force with immediate effect.
