2. To confirm the admission, you are required to pay the requisite fees on or before **3rd August, 2022**.
3. You should convey the whole details like (App. No., Program etc.) UTR No. / Transaction ID etc. via e-mail to vikramjeet@iitmandi.ac.in, girishpal@iitmandi.ac.in and sbsoffice@iitmandi.ac.in on or before the last date of payment. Please retain a copy of the receipt of the online payment made by you.
4. You are required to convey your acceptance of this offer via email to sbsoffice@iitmandi.ac.in. Once Offer is accepted you are required to report for the **admission** at the School Office, A-7 Building, South Campus, IIT Mandi alongwith (i) scanned copies of all the testimonials starting from Matriculation (10th onward), (ii) Address Proof (iii) Aadhar Card (iv) Valid Category certificate, if applicable (v) scanned signature (vi) Photograph (vii) Physical Fitness Certificate (viii) JAM Score Card
5. You will have to register for the courses. Please visit IIT Mandi website for further updates on the Academic Calendar. Classes will begin from **10th August, 2022** and you are required to attend the classes. The date of registration in the programme would be 10th August, 2022.
6. The date of **reporting and document verification schedule will be communicated separately**.
7. Applicants in the GEN-EWS(Economically Weaker Sections) and OBC-NCL(OBC Non-Creamy Layer) categories are required to submit valid category certificate in prescribed formats issued on or after 1st April, 2022. SC/ST PwD applicants are required to submit valid category/disability certificates in the prescribed formats as per rules.
8. At the time of joining you will be required to undergo medical examination at the Institute's medical unit and submit medical fitness certificate
9. If you do not report for registration or fail to submit any document regarding your academic qualifications/experience at the time of joining to the institute the offer of admission would automatically stand cancelled, even if the fee is already paid and only refundable amount will be refunded.
10. The admission is **PROVISIONAL** subject to fulfillment and verification of all the Academic and Non-academic requirements. At the time of joining, you must fulfill the Eligibility and shortlisting criteria as per the advertisement and/or in the Ordinance & Regulations of the Institute. Failure to meet eligibility and/or other criteria and/or furnishing any false information/forged/manipulated documents will lead to suo- moto cancellation of admission.
11. In case of withdrawal from the program, refund will be done as per the withdrawal policy of the institute (as mentioned below).

Academic/Institute Fee:

- i) If the withdrawal is requested **on** or **before** the date of Registration, full fee may be refunded after deducting processing fee of Rs.1000/- (Rs. One Thousand only).
- ii) If the withdrawal is requested **after** the date of Registration, only Caution/Security/Refundable deposits may be refunded (after adjusting the dues, if any).

Hostel Rent/ Charges:

- i) The Caution/Security/Refundable deposits may be refunded (after adjusting the dues, if any).
- ii) If the withdrawal is requested **before** taking possession of / occupying the hostel room, full rent/charges may be refunded.
- iii) If the withdrawal is requested **after** taking possession of / occupying the hostel room, the hostel charges may be refunded on proportionate deductions of monthly charges/seat rent, Mess charges, etc. where applicable.

12. You will be governed by the Rules & Regulations of IIT Mandi, in force from time to time.
13. During the period of study when you are a resident of the campus, the use of a powered vehicle inside the campus is strictly not allowed. This is with a view to keep our campus clean.
