In the larger interest of the applicants and as per requests received from some Higher Educational Institutions, this is to inform all concerned applicants that an additional opportunity has been given for registration and application.

In this regard, the following points are to be noted:

- 1. **Students who have yet not registered or applied** will be able to register and apply at https://assamadmission.samarth.ac.in/ (UG admission portal)
 - a) It is also be noted that admission to UG programme (FYUGP, FYIMP, FYIPGP) shall be considered valid for admission processing only if the following steps are followed in Assam State Higher Education Admission Portal:
 - **Step 1:** Register and verification of registration using OTP that would be received in registered Mobile number and email ID.

Step 2: Profile Lock

Step 3: Submit application

Step 4: Print form (or download as PDF)

- 2. The already registered applicants, who have not yet exhausted all six options, will get a chance to submit their application(s) afresh. In the case of applications/forms initiated earlier but which remained as "not submitted" applications/forms, the applicants can now submit their incomplete applications provided they have not exhausted all six options. It is to be categorically noted that registered applicants will not be allowed to "Edit" or "Discard" the "Submitted" applications/forms.
- 3. Applicants are advised to proceed carefully because once the application is submitted, no correction/modification will be allowed to that form. The Colleges/Universities can simultaneously proceed with academic scrutiny of such new forms along with the forms submitted earlier, in the case of any forms are yet to be scrutinized.

Kindly refer to the admission notices/ notifications in the admission portal and proceed with the admission process accordingly. All necessary information will be updated in the "public notice" section of the admission portal. The window for submission will close on 9 P.M. of 14th June, 2024 (Friday).
